EMT REGISTRATION FORM



Course Description

This course is geared toward getting students comfortable performing in an emergency situation. The EMT-Basic is able to control life threatening bleeding, provide basic cardiac life support for a patient, as well as maintain an airway, splint an injured extremity, and administer lifesaving medications.

Course Coordination

This EMT-Basic course is being conducted in accordance to the National Standard Curriculum for Emergency Medical Services Education as published by the National Highway Traffic Safety Administration, and is approved by the Illinois Department of Public Health and the Peoria Area EMS System.

Testing

At the completion of this course, participants can challenge the Illinois State EMT-Basic test, or the National Registry of EMTs Basic test.

Cancellation Policy

- 10 or more participants are required for each class. Class will be cancelled if less than 10 participants are registered.
- Non-attendance will result in forfeiting the course fee. Non-attendance includes cancellation with less than 24 hours notice.
- The EMS Course Coordinator and the EMS System Manager have the ability to make exceptions to the cancellation policy.

Requirements

Current/valid Healthcare Provider CPR Card, Background/drug screen, High school diploma or GED, 18 years of age at time of state or national testing. Health Information as required below.

Health Information

You must submit proof of a recent physical examination (within one year), as well as tuberculosis (TB) testing and certain immunizations before you will be allowed into the course. Immunizations and physical exam can be obtained at a healthcare provider of your choice or from OSF Occupational Health. Note - you may have already have many or all of the required immunizations and or examinations from regular visits to your doctor, or if they are required by your employer or the military. (The cost of this is not included in the course fee).
